AMENDMENT OF CAO No. 1-2013 ON PROVIDING FOR NEW SUBJECT: RATES OF SERVICES, STORAGE AND OTHER CHARGES ON GOODS OR MERCHANDISE STORED AT CUSTOMS BONDED WAREHOUSE (CBW) NOS. 31, 55, 83, 124, 125, 182 and 185 OPERATED BY PHILIPPINE SKYLANDERS INT'L. (PSI), INC.,

PHILIPPINE AIRLINES, PEOPLE'S AIR CARGO (PAIRCARGO), DELBROS, CARGOHAUS, DHL PHILIPPINES

WORLDWIDE EXPRESS, WITHIN NAIA COMPLEX

INTRODUCTION. This CAO implements Sections 201 and 204, Chapter 1, Title II of Republic Act No. 10863, otherwise known as the Customs Modernization and Tariff Act (CMTA).

Section 1. Scope. This CAO shall be applicable to Customs Collection District III – NAIA and the different Public Bonded Warehouses.

Section 2. Objectives.

- To provide new rates of service, storage and other charges on 2.1. imported goods or merchandise stored in CBWs being operated by the PSI Inc., Philippine Airlines, PAIRCARGO and Warehousing Co., Inc., Delbros Inc., Cargohaus Inc., DHL Express Philippines Inc. and TMW Worldwide Express, all Customs Bonded Warehouses within the NAIA Complex;
- To standardize various charges for the operations affecting 2.2. imported goods before actual delivery to the importer or consignee and taking into account the present economic conditions and the facilities given by CBW operators, the service, storage and other charges on goods or merchandise stored in CBWs; and
- To provide clear and transparent regulation to stakeholders in the collection of rates of service, storage and other charges on goods or merchandise stored at Public Bonded Warehouse.

Section 3. Classification of Goods or Cargo.

General Cargo. All goods not included in the below enumeration for special cargo, each kind, class or nature is described herein.¹

- 3.2. Special Cargo are classified as follows:
 - **3.2.1. Baggage and Personal Effects** shipments that are handled with special care and provided special storage locations.²
 - **3.2.2. Perishables** shipments shown as such in the Cargo Manifest (CM) and Airway Bill (AWB) or labeled or identified on the package(s) as such, hence requiring storage under specified temperatures. (e.g. All aquatic products fall under this classification).³
 - **3.2.3. Valuable Cargo** shipments shown in the CM and/or AWB as such or so labeled or identified on the package(s) pursuant to IATA regulations.⁴
 - 3.2.4. Restricted Goods except when authorized by law or regulation, the following restricted goods are prohibited:
 - a. Dynamite, gunpowder, ammunitions and other explosives, firearms and weapons of war, or parts thereof;
 - b. Roulette wheels, gambling outfits, loaded dice, marked cards, machines, apparatus or mechanical devices used in gambling or the distribution of money, cigars, cigarettes or other goods when such distribution is dependent on chance, including jackpot and pinball machines or similar contrivances, or parts thereof;
 - Lottery and sweepstakes tickets, except advertisements thereof and lists of drawings therein;
 - d. Marijuana, opium, poppies, coca leaves, heroin or other narcotics or synthetic drugs which are or may hereafter be declared habit forming by the President of the Philippines, or any compound, manufactured salt, derivative, or preparation thereof, except when imported by the government of the Philippines or any person duly authorized by the Dangerous Drugs Board, for medicinal purposes;
 - e. Opium pipes or parts thereof, of whatever material; and
 - **f.** Any other goods whose importation and exportation are restricted.

- **3.2.5. Livestock and Plants** live animals and plants which need special attention and feedings.
- **3.2.6. Human Remains -** Coffins or urns, bones or ashes of the deceased person.



Section 8. <u>Periodic Review</u>. Unless otherwise provided, this CAO shall be reviewed every three (3) years and be amended or revised, if necessary.

Section 9. Repealing Clause. This CAO specifically amends or repeals CAO No. 1-2013.

Section 10. <u>Separability Clause</u>. If any part of this CAO is declared unconstitutional or contrary to existing laws, other parts not so declared shall remain in full force or effect.


Section 11. <u>Effectivity.</u> This CAO shall take effect thirty (30) days after its publication at the Official Gazette or a newspaper of national circulation.




